

Presentation

The Abrigo Grande of Minateda is a classic site of the Rock Art Heritage in Spain, being the largest known assemblage of Levantine style art. It is a large -and well visible- rocky shelter overlooking a plain crossed by streams (generally seasonal) tributaries of the Mundo River, in which there is a monumental panel of almost 18 m in length where more than 600 painted graphic units have been documented, most of which can be assigned to the Levantine cycle (with some dozens that can be included in the so-called Peninsular Schematic Art).

Discovered in May 1914 by Juan Jiménez Llamas, it was studied by H. Breuil and other specialists throughout the 20th century. More recently, it has undergone restoration to improve the reading of its cave paintings and archaeological studies using modern technologies. This overcame a worrying situation due to the state of the paintings, which had deteriorated considerably after decades of bad practices during visits, and the lack of updated studies to incorporate this site into the current scientific discourse.

Since 1998, the shelter has been included in the UNESCO World Heritage List, as part of the serialised declaration number 874, called "Rock Art of the Mediterranean Arc of the Iberian Peninsula" (ARAMPI https://whc.unesco.org/es/list/874).

In 2010, it was registered in the Programme of Cultural Routes of the Council of Europe <u>https://www.coe.int/en/web/cultural-routes</u> by the Junta de Comunidades de Castilla La Mancha and with the inauguration in 2019 of the Archaeological Park of Tolmo de Minateda, it was attached to this infrastructure - theoretically-to be managed for cultural and tourist purposes.

Despite all, at present times, this unique rock art site (that Henri Breuil called the "Altamira of Southern Spain") lacks a managing plan and is practically closed to the public due to the lack of a programme of presentation to the public and staff in charge of its management.

The recent concession to Hellín Town Council of a Tourism Sustainability Plan by the Ministry of Industry, Commerce and Tourism of the Spanish Government (called "Destino Hellín 2 Patrimonios 2022-2024": Development of the tourist corridor from Minateda to Las Minas, Green Way of Camarillas -PSDT Hellín-), in which the Abrigo Grande de Minateda appears as a preferential destination for action, opens up a unique opportunity to overcome the current situation, in terms of its cultural and tourist management.

This Programme for the improvement of the tourist offer of the municipality of Hellín will make it possible to dignify the place and provide it with a Master Plan for the use and integral management of both the shelter and its natural and archaeological surroundings.

Thus, and as a first step to tackle the investment in Minateda, the Town Council of Hellín (through the Management Entity of the PSTD Hellín) has considered it appropriate to hold a technical working meeting to guide and train the technicians responsible for the PSDT Hellín in the process of the material execution of the specific project that will provide to the Abrigo Grande with areas and resources for the reception, access and visit to the site with parameters of sustainability and guarantees of visitors satisfaction.

The experience and knowledge of the members of the Scientific Committee of the Council of Europe's Cultural Route "Prehistoric Rock Art Trails", as well as the contributions of local and regional experts, form the basis of this expert information exchange event. The conclusions of this Workshop will serve as the basis for the Manging Plan that will guide the development of the exploitation model for the Abrigo and its immediate area.



Objetives

The main objective of the Workshop is to provide the Hellín PSTD Management Entity with the appropriate technical guidelines for the material execution of this plan, in terms of the comprehensive management of the shelter and its landscape and archaeological environment, establishing the best practices that should head the design, execution and implementation of the new model of presentation to the public of the Shelter and its surroundings.

More specifically, other objectives can be related, such as:

- To obtain contrasted information on visit models for the Abrigo Grande de Minateda, based on the sustainability criteria developed by international bodies for rock art sites (UNESCO-Council of Europe).

- Obtain information on contrasted offers of structures for the protection, reception and approach to the site, from similar rock art sites.

- To learn about reference experiences for the design of the future Minateda Visitors Reception Centre.

- Ways of establishing and applying an integral management plan for the rock art destinations in the municipality of Hellín, agreed with the regional (Regional Council of Education, Culture and Sport of the Junta de Comunidades de Castilla La Mancha), provincial (Provincial Council of Albacete) and local (Town Council of Hellín and local town hall of Minateda) administrations.

- To learn about the process for obtaining the European Rock Art Heritage - European Rock Art Heritage quality seal <u>https://www.prehistour.eu/es/el-sello-sera/</u> for the rock art destination formed by the PSTD Hellín, ariund the Abrigo Grande.

Structure of workshop

The expert information exchange workshop "Rethinking Minateda" is structured around two groups of activities. On the one hand, a first workshop *in situ* (at the site), in which the participants learn first-hand about the current situation, its problems and shortcomings. And on the other hand, three sessions of presentations and discussion tables (focus groups) linked to analyse the current state (and the reasons for it), the idea that the Management Entity of the PSTD Hellín has in its programme for the intervention in the site and, finally, a brainstorming that the members of the Scientific Committee of the Council of Europe PRAT-CARP Cultural Route will generate from their professional experience and the good practices that should govern the material execution of the Managing Plan for the new rock art destination to be generated in Hellín.
